When you ship your products to Japan, you must get an import permit from Japanese Customs.

There are 2 ways to declare to Japanese Customs: setting up a Japanese Legal Entity as importer or appointing a Japanese Customs broker as your Attorney for Customs Procedure (ACP).

Our ACP service is responsible for the products you declare will comply to the Japanese laws, and also responsible for the price you declare will conform to the Japanese tariff law.

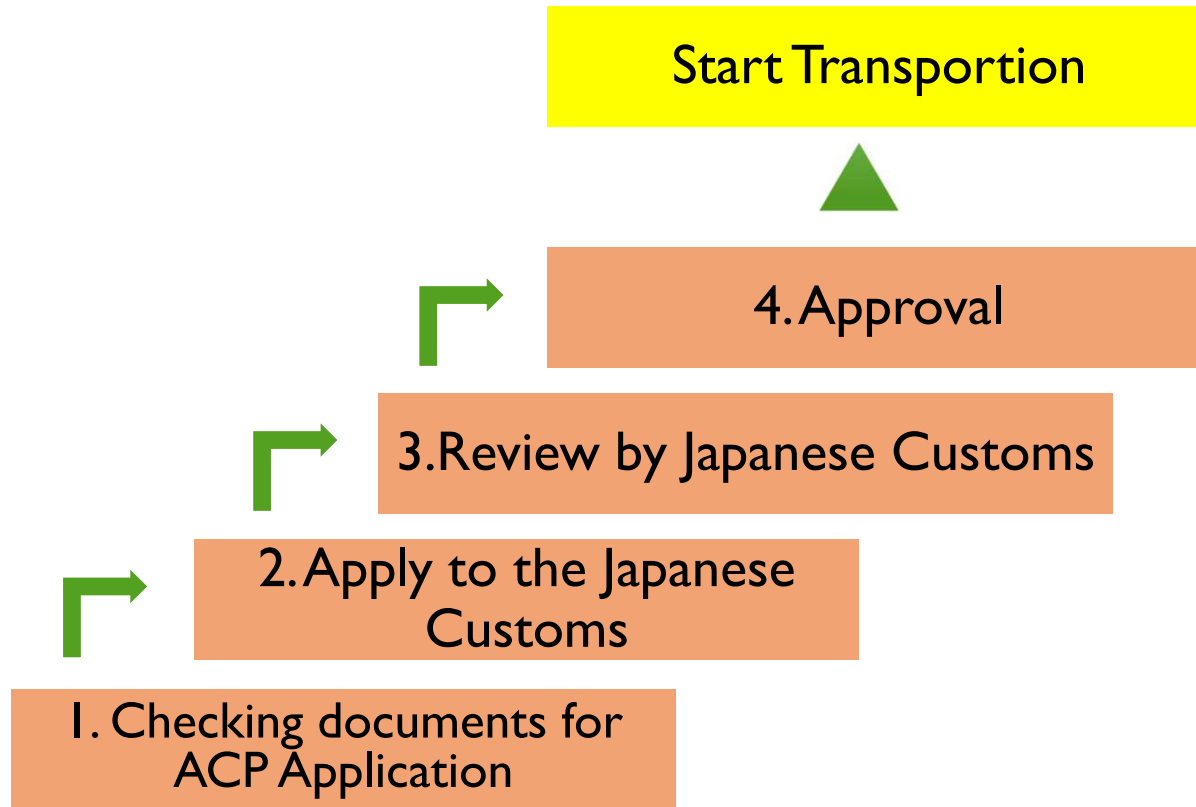
However ACP cannot be applied for the products such as Foods & Beverages, Infant toys, Kitchen goods, Pharmaceutical items and Cosmetics.

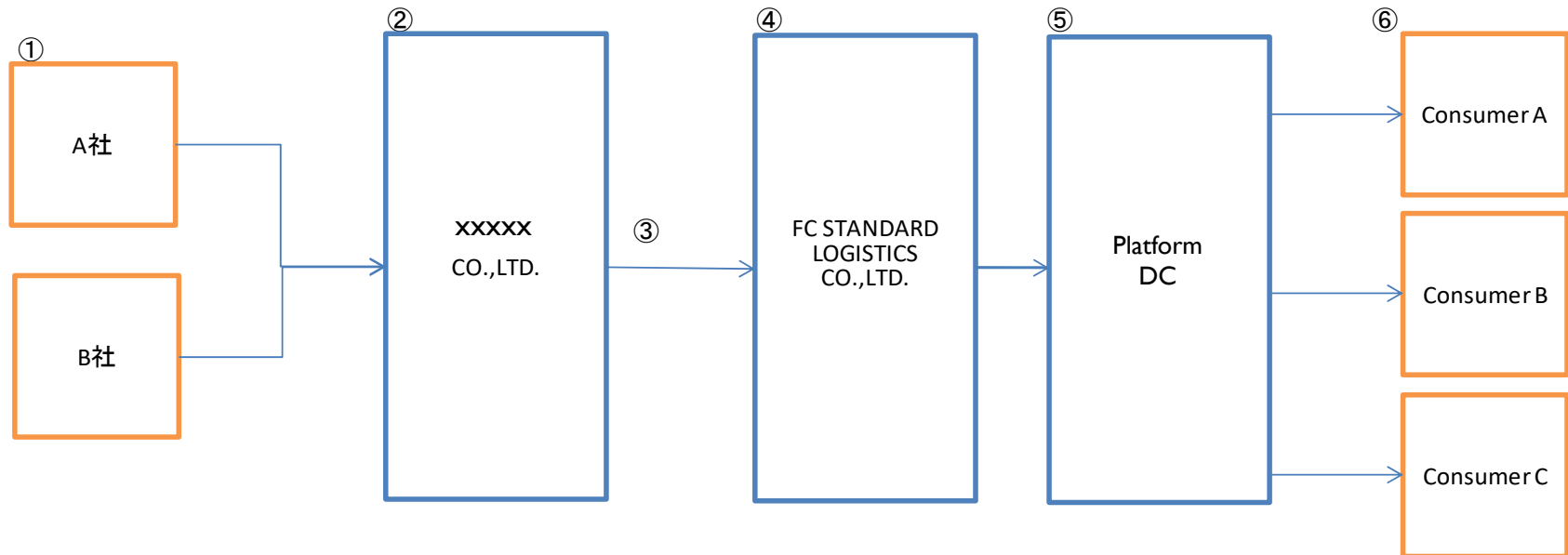

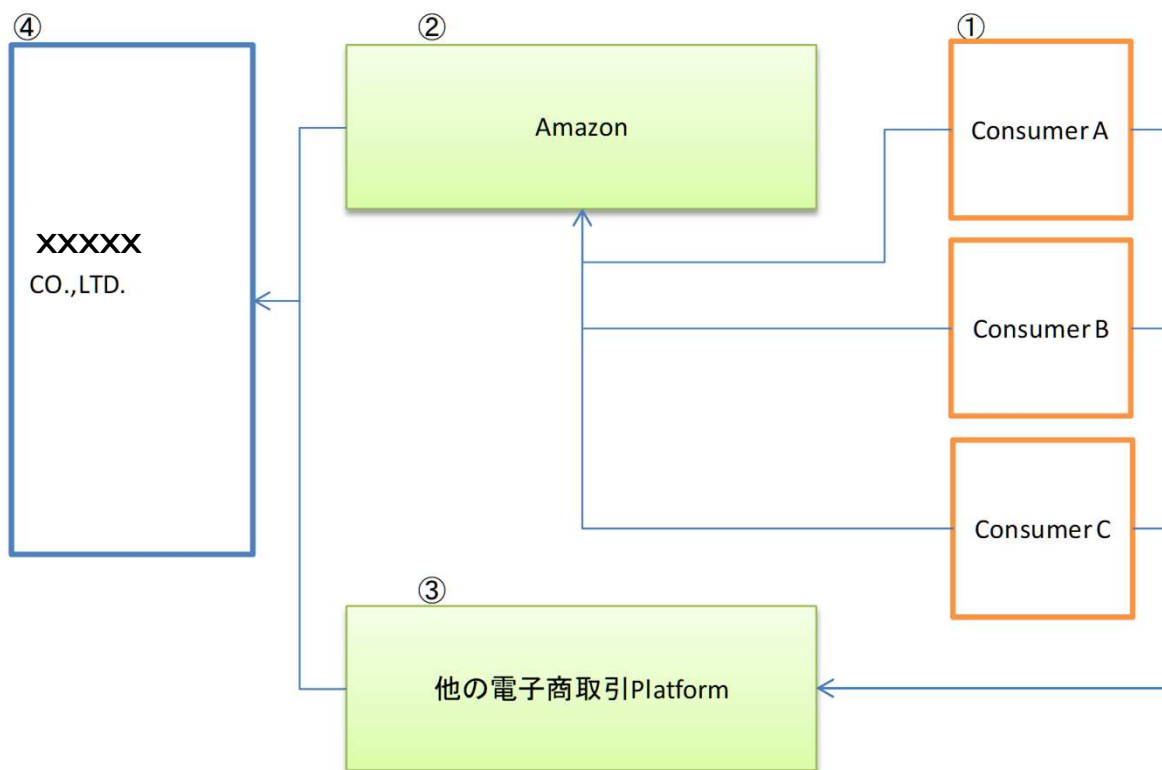


Flow Chart for Transportation
